Gov Trek

Gov Trek is an exciting new AAUW California offering to encourage young women who are currently juniors or seniors in high school to get inspired to run for public office or seek careers in public service. Starting in January 2023, this online, virtual program will run on five Saturdays for two hours each and conclude in late March 2023. It is a great program for those interested in issues of social justice. It will provide valuable leadership training and campaigning skills, and look good on a college application.

What does our branch need to do to bring this program to our community? To participate, we need to advertise the program at local high schools so that the students learn about it and apply. The deadline to submit online applications is January 14, 2023. There isn't much time! However, we do not need to select students. Acceptance will be on a first-come-first-serve basis, until all of the 150 open positions are filled.

Advertising materials – posters and social media posts have already been created by AAUW California and are ready for use. What we need is an individual to lead this effort for our branch and reach out to some local high schools. If we can get even 2-3 students to register for this program, that would be great!

Astronomer Extrordonaire



While studying astronomy at Georgetown in the 1950s, Vera Rubin, a young mom, was also juggling childcare issues similar to those facing women today. Her goal was to study how entire galaxies were spinning..Some years later, she would become the first woman to legally be allowed to use the telescopes at the Palomar Observatory in California.. It puzzled her that the galaxies that she wished to study were spinning very rapidly as if something more massive but invisible was holding them together. Her research demonstrated that every galaxy is surrounded by a huge halo of energy. Her work convinced the astronomy world beyond a doubt that dark matter really exists and deserves much more study.

Fifty years later, we still have much to learn about what dark matter actually is. Vera's achievements continue to inspire women across the world to enter the field of astronomy. Her discovery of galaxy rotation rates turned the world of science on its head.

Vera Rubin received many scientific awards due to her painstaking research of spiral galaxies. She was a member of the US National Academy of Sciences and the Pontifical Academy of Sciences but she never got her Nobel.

With Vera in mind, in June of 2019, the renaming of an observatory with a large synoptic survey telescope was initiated by two influential women: Eddie Bernice Johnson, a member of the House of Representatives from Texas, and Jennifer Aydin Gonzalez Colon, a Puerto Rican politician who currently serves as the Resident Commissioner of Puerto Rico. Currently under construction on the coast of Northern Chile is the Vera C. Rubin Observatory..Financial support came from both the public and private sectors but includes the Department of Energy and the National Science foundation. Long in the planning stages, site construction actually began in 2015 and is nearing completion. Next year, data collection from the huge telescope (actually the largest digital camera ever built) should begin and hopefully become fully public

in 2025. Helen's research and that of other astronomers who have followed in her footsteps will move a giant step forward.

Marie Curie & AAUW

The year was 1919. Europe had been ravaged by World War I and radium was far too expensive for a scientist of modest means to afford for experiments. This was true even for one as famous as Madame Marie Curie. As a result, her groundbreaking research had reached a virtual standstill.

Then the AAUW came to the rescue. Members from Maine to California helped raise an astonishing \$156,413, enabling Madame Curie to purchase one gram of radium and continue her experiments that helped her create the field of nuclear chemistry and forever change the course of science. Madame Curie received the Nobel Prize for her work, but was not admitted to the French *Academie des Sciences* until she won an incredible second Nobel Prize...all because she was a woman. More than 75 years later, there are still only three women members.

Pay Equity

AAUW has been on the front lines fighting for Pay Equity for over a hundred years.

AAUW was there in the Oval Office in 1963 when President John F. Kennedy signed the Equal Pay Act into law.

AAUW was there in 2009 when President Barack Obama signed the Lilly Ledbetter Fair Play Act into law.

AAUW continues the fight for the passage of the Paycheck Fairness Act to ensure women have further equal pay protections. The pay gap is real.

AAUW will continue the fight to achieve pay equity; the economic security of American families depends on it.

Legal Advocacy Fund

Founded in 1981, the Legal Advocacy Fund (LAF) works to achieve equity for women in higher education by recognizing indicative efforts to improve the climate for women on campus; by offering assistance to women faculty, staff, and students who have grievances against colleges and universities; and by supporting sex discrimination lawsuits.

The LAF Board only approves support of cases which are currently involved in litigation, and that have the potential to set legal precedent.

The Legal Advocacy Fund's annual Progress in Equity Award recognizes indicative and replicable college and university programs.
